NEW HIRE- Todd Wells moved to open the SPED paraprofessional position. Kim Taylor seconded. Motion carried.


PRINCIPAL REPORT- Elementary Principal Chuck Day reported on enrollment numbers, I station runners and the dance party next Friday.
